Parents and Students,

In 2006 the Federal Government passed new legislation that affected the treatment of Qualified Education Benefits (QEBs), such as IRS 529 prepaid tuition and saving plans (FL Prepaid, TX Prepaid, AL PACT) in determining student aid eligibility.

It is the institution's responsibility to ensure that the value of the plan is correctly included in the student's Estimated Family Contribution (EFC) from the FAFSA.

***The value of the asset for Saving Plans or Education Saving Accounts is the liquidated value of the account at the time the FAFSA is completed***

The value to be reported is the refund value of any tuition credits or certificates purchased under the QEB. The refund value of a prepaid plan is the amount the owner would receive if the account was liquidated as of the date the asset is reported on the FAFSA. This value should be available from the QEB plan's administrator.
